Minutes

1. Welcome / Introductions

The October 2018 meeting of the Downtown Neighborhoods Association was held in the library of Lew Wallace School, pursuant to prior approval.

Board chair Holly Siebert called the meeting to order at 6:55. Eight board members were present: Noelle Baroody, Jim Clark, Asra Elliott, Daniel Gutierrez, Melanie Lewis, J.J. Mancini, David McCain and Holly Siebert. Two board members were absent. Five other neighbors and guest speakers also attended.

2. Agenda revisions / approval

The agenda was approved. The September 5 minutes were approved. There was no treasurer's report since the treasurer's position is vacant. David McCain is recorded as a check signer with the Bank of Albuquerque.

The vacant APD substation at Central and Rio Grande Blvd may be staffed.

Chan Graham described his latest DNA book. He has gotten four printing quotes. He prefers the quote from A Good Sign: 500 books at \$8.96 for a total of \$4479.99. At the September 2018 DNA meeting, the board approved up to \$2500 for printing. Combined with the \$2500 County grant, there is a maximum of \$5000 available for printing. Chan will work with A Good Sign to produce the book. There was a discussion of marketing. Chan said that he would not be much involved with promoting and delivering this book.
